

# Mr. Third Coast Gear 2018 Application

## Requirements and Expectations:

### Requirements:

- Identify as a gay or bisexual male
- Be a resident of a Gulf Coast state or territory (*contact us if uncertain if your residence qualifies*)
- Compete in his own gear

### Expectations:

- To promote sport gear fetishism nationally (and internationally)
- To promote the Mr. Third Coast Gear contest nationally (and internationally)
- To promote G.L.U.E. Weekend nationally (and internationally)
- To make a minimum of three (3) public appearances as Mr. Third Coast Gear at gay male fetish events in the Gulf Coast states and territories during his title year
- To attend and assist in the following year's Mr. Third Coast Gear contest
- To maintain good standing in the community through presenting himself with integrity
- To NOT create or promote a competing contest/weekend event
- To refrain from publishing or broadcasting any professional pornography during your title year

### Scoring:

Contestants will be scored on how well they represent themselves in their application on stage. They will be judged regarding stage presence, personality, & embodiment of sport gear fetishism, and physique.

### Contest Categories:

- Application
- Solo sports gear (e.g. wrestling, swimming/diving, track, racquet sports, boxing/UFC, cycling, etc.)
- Team sports gear (e.g., football, baseball, basketball, soccer, hockey, lacrosse, rugby, etc.) and erotic sports gear fantasy (not to exceed 4 minutes)
- Athletic jock and Q&A from judges

### Judging:

Contestants will be judged on the aforementioned categories by a panel of three judges. Points awarded by the judges will be added together for each contestant and the contestant with the cumulative highest number of points will be declared the winner. In the event of a tie, the lowest category scores for the top contestants will be eliminated until a winner can be declared.
